FROM THE ENGINEER

We have received a preliminary list of the District 5 SCIP and LTIP projects for Round 26. Sandusky County didn't fare too well. We received no LTIP grants and only three SCIP- Clyde, us, and the townships. Our application is for resurfacing CR's 12 and 39. The township application for paving is a combination of several townships for various roads. This list has not been formally approved yet and I am sure ratings will be scrutinized in the meantime. LTIP ratings were particularly high with a cutoff of 107, last year it was 101. We are still in line for funding for CR's 2, 82 and 169 from Round 25, but with each passing day, that becomes less of a possibility.

The TR 226 Turnpike overpass is now open. We had a walk through inspection on October 11th. My biggest objection was the condition of the asphalt curbs. Sections are very poorly done and they stick out from the face of the guardrail and could therefore be wiped out by a snow plow. We were informed the curbs weren't necessary because the embankment is free draining. I asked that be put into the minutes of the meeting, which it was. The Township said they would not replace any curb that was damaged. The TR 222 overpass is to be closed at noon today due to its poor condition.

The work related to Fremont's new reservoir on South River Road is coming to a close. It appears they have provided an adequate outlet for the water from the pumping station, but the water from the reservoir area itself may still need some attention. The objection is to prevent runoff now being directed to the road from actually reaching the road.

We have now had the view and the preliminary hearing for the Cedar Ridge Ditch which is the first petitioned ditch we have had in quite awhile. Ironically, the pipe that is too high and probably prompted the need for the petition was lowered the same day as the hearing!

The latest "subdivision" has also been completed. Although it is a subdivision, the biggest portion of it is the road itself. The road is an extension of the previously accepted Hampton Court leading to the Hampton Inn. One of the purposes of

the extension is to accommodate the new Holiday Inn Express currently under construction.

On Tuesday October 18th we opened bids for guardrail on CR 117 and equipment for the two new tandems that have been ordered. Lake Erie Construction was the only bidder for the guardrail at \$97,275. Hopefully that will be completed before the end of the year. Newell Equipment was low on the trucks, but we recommended the bid be awarded to Judco since Newell has not completed the single axles which had a completion date of October 1st. Judco's bid of \$90,000 was \$344 more than Newell's.

I think every business should give something back to community in which they operate. Our operation is no different, but it's more difficult for a government operation to give back, especially one like ours that is countywide. We cannot make direct cash payments, and we need to do something that benefits the whole county and not just one community. That's one of the reasons we do work at the county fairgrounds. What I am getting at is the United Way. This is the time of the year for their annual fund raising drive. In general, Sandusky County has been a very poor contributor when compared to private businesses. Work at the fairgrounds comes from our budget and not from individuals.

United Way is different; contributions come from employees and not the County. I would encourage all employees to consider contributing. Contributions as low as \$1 per pay check can be deducted automatically. Although we all could use more money, overall we have it pretty good as county employees. I don't think it would hurt any of us to give a little to an organization that sooner or later that will most likely benefit about everyone or everyone's family in the county. I hope all our employees will seriously consider becoming donors.

ROAD MAINTENANCE

- Roads were run for high water.
- Ceiling tiles were replaced in building #2 that were needed.
- Berming on CR 32 was finished, and now started on CR 1.
- The new pickups and dump trucks were washed and waxed.
- Washout on CR 90 was repaired from the high water.
- Drainage tiles were repaired on CR 232 and CR 312
- Catch basin was rebuilt on E. State St.
- The culvert on CR. 90 was paved.
- Steel has been cut for CR 232 bridge work.
- Culverts are being replaced on CR 117.
- Culverts on the inspectors list are being repaired.
- Wo56-1.20 and Ja31-0.25 were waterproofed for paving.
- Misc. spot berming on 061's route and washouts.

MOWING

The west side of the county is done except C.R.41 between S.R.590 and C.R.132. The boom mower went out last week and is working in the northwest part of the county. If the crops ever come off we will be able to finish the back banks.

SALT

We got in 1,000 tons of salt which filled the salt shed to about ½ capacity; we have another 3,000 tons to get by the end of April.
